A clear sign has been installed to indicate the entrance on the car-park side of the building. Clear Male/Female symbol signs have been placed on the changing room doors. The space is less than ideal but adequate, so long as the area is kept free from clutter. No improvement could be effected without significant structural alteration.

3.2	The Club has Accessible changing provisions for Disabled People.	✓	Access to both changing rooms is wide enough to permit wheelchair entry. There is a seat in both shower areas for those unable to stand. However, the entrance to the shower itself in both cases is not wide enough to permit wheelchair access. It is thought that structural changes to widen the access while theoretically possible would involve considerable expense.

4.1	The water can be easily accessed from the main club facilities.	√		Access over the small grassy area to the waterside is easy in dry weather but could potentially be very difficult for wheelchair users when muddy.	
4.2	The waterside facilities are such that it is easy to support a disabled person in and out for a craft should they need it.		✓	Support difficult due to nature of the bank, and little if any scope for improvement.

	Ease of use of the landing stages		Considerable improvement to the safe use of the landing stages (for all, but especially those with mobility and sight issues) could be made by repair or ideally complete replacement. Materials have been acquired to reinforce the ground around the landing stage. Installation of non-slip surfacing on the stage should be investigated. A project to completely replace the landing stage is being actively pursued.	ongoing
